#0 George Brown Concord Classics	Red Card – fighting (instigator)	Three (3) game suspension to begin on Sun, Jul 14, 2019.
#2 FC Tenancingo	Red Card – fighting (instigator)	See team penalties below
#3 FC Tenancingo	Red Card – foul in the box	See team penalties below
#14 FC Tenancingo	Red Card – violent conduct (attempting to injure opponent)	Two (2) year suspension from all NCC Sports programs. Probation through Dec 31, 2023.
#20 FC Tenancingo	Red Card – violent conduct (spitting on opponent)	One (1) year suspension from all NCC Sports programs. Probation through Dec 31, 2022.
FC Tenancingo Team Ivan Garcia, Manager	Multiple red cards for players leaving the bench during an altercation. Spectators entering the playing area during an altercation Repeated violation of league policies regarding player conduct	Forfeit of all remaining games. All players must be identified before any Tenancingo team may participate in NCC Over-35 or Co-Rec leagues. Two (2) year probation upon return.
#8 Brooks soccers11.com	Red card – fighting (non-aggressor)	Two (2) game suspension to begin on Aug 11, 2019.
