# NEW CASTLE COUNTY GOVERNMENT DEFERRED COMPENSATION COMMITTEE MEETING MINUTES of 10/08/2020

#### **Meeting Summary**

Frank welcomed everyone and called the meeting of the Deferred Compensation Committee to order.

#### **Old Business**

First item discussed was the request to approve the minutes for 09/10/2020. A copy of the minutes was previously distributed to members. Does anyone have any questions or comments on the minutes from September 10, 2020 Deferred Compensation Committee meeting? If not, I would like to entertain a motion to approve the minutes.

Wilson Davis made a motion to approve the minutes of the September 10, 2020 meeting. The motion was seconded by Jacqueline Jenkins and approved.

#### > Composition of the Deferred Compensation Committee

Frank - A copy of the draft ordinance to amend NCC Code 26.03.206 (Deferred Compensation Plan) was previously distributed. The draft ordinance intent is to reorganize the composition and roles of each member in an effort to assist the committee in carrying out its functions more effectively. Does anyone have any questions or comments on the recommended Deferred Compensation Committee composition?

Wilson Davis made a motion that the committee authorize Frank Benevento to find a sponsor for the ordinance. The motion was withdrawn.

Wilson Davis made a motion that Frank Benevento contact Sue Moore to get a time-line on presenting the ordinance and finding a sponsor. The motion was seconded by Jacqueline Jenkins and approved.

# Consulting Services

Frank - This is a follow up to the discussion that was held at our September 10, 2020 Deferred Compensation Committee meeting.

The discussion included a best practice would be to obtain a consultant to provide investment advisory and consulting services for the Committee. To seek a firm to complete a best practice review that would include a review of current vendor (MetLife), plan design and investment architecture, fee/benchmark analysis and governance best practices. The firm would also provide RFP services for third-party to provide administrative, compliance, record keeping and investment management services.

It was also noted that these services are what's considered a Plan Sponsor (New Castle County) expense and funding for these services will have to be determined by Finance.

#### > 457(b) Deferred Compensation Plan Review MetLife (Follow-up)

Frank - This is a follow up to the NCC 457(b) Deferred Compensation Plan review presented during our last Deferred Compensation Committee meeting on September 10, 2020.

Typically, MetLife would present a follow-up to our plan review and discussions. During our discussions, the Deferred Compensation Committee noted similar concerns on a few investment options offered to our participants as did the New Castle County Employees' Pension Board of Trustees. It was determined by the Pension Board to hold further discussion at their next meeting on governance and plan development when deciding on investment lineup changes. It is my recommendation to the Deferred Compensation Committee to wait and see the outcome of the Pension Boards direction before any formal decisions are made.

# New Castle County 457(b) Deferred Compensation Plan (Membershp requirements and investment options)

Frank - 1<sup>st</sup> New Castle County 457(b) Deferred Compensation Plan (Membership requirements and investment options)

Membership Requirements:

Eligible - Full-time regular or permanent employee

<u>Ineligible</u> – Part-time regular or temporary employee (NCC Code Sect. 26.03.511) – not eligible for fringe benefits

Ineligible – See chart

There are a couple membership requirements and an investment option we would like the Deferred Compensation Committee to consider.

- 1. Auto enrollment and auto escalation for all new hires
- 2. Participation eligibility open to part-time employees
- 3. Consider a Roth IRA investment feature

Make Note: We will be pushing out an email campaign in conjunction with our 457(b) Deferred Compensation Plan provider in the coming weeks. Inform members of eligibility and enrollment options.

Wil – For Part-time employees, is it commonly offered by the Public Sector and any drawbacks in offering this to part-time employees?

Frank – Will research this for Public Sector plans.
